RESOLUTION NO. 573, S-2022

REQUESTING THE HONORABLE MAYOR, LEOPOLDO N. BATAOIL TO PUT UP WATER TREATMENT FACILITIES PARTICULARLY AT THE LINGAYEN BAYWALK, THIS MUNICIPALITY.

WHEREAS, Section 16, Chapter I, Title I, Book I of Republic Act 7160, otherwise known as the Local Government Code of 1991 expressly provides that Local Government Units (LGUs) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, LGUs are responsible in the management and improvement of water quality within their territorial jurisdiction;

WHEREAS, the mushroom-growth of residential and commercial establishments at the Lingayen Baywalk area has given rise to pollutants in waste water due to the absence of proper waste management systems in place;

WHEREAS, the sewage and other wastes from these homes and establishments - if not properly managed - can make its way to the Lingayen Gulf, which may potentially make the water dangerous because of the presence of many water-dwelling organisms, pathogens, and bacteria that could cause health-related issues in humans and fishes alike;

WHEREAS, since water is an extremely valuable resource, there is a need for proper water treatment policies and management particularly in the Lingayen Baywalk area which has evolved into a commercial and tourism hub in this capital town;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request the Honorable Mayor, Hon. Leopoldo N. Bataoil to put up Water Treatment Facilities particularly at the Lingayen Baywalk, this municipality.

RESOLVED FURTHER, that a copy of this resolution be furnished to Mayor Bataoil for his information and appropriate action.
