RESOLUTION NO. 585, S-2022

ADOPTING THE NEW DAILY MINIMUM WAGE RATES OF WORKERS AND EMPLOYEES OF WAGE ORDER NO. RB 1-20 OF THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) IN THE LOCAL GOVERNMENT UNIT OF LINGAYEN.

WHEREAS, Section 447 A-1 (VIII) of R.A. 7160 states that the sangguniang bayan, determines the positions and salaries, wages, allowance and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

WHEREAS, the Regional Tripartite Wages and Productivity Board No. 1 (RTWPB-1) is mandated under R.A. 6727 (The Wage Rationalization Act) to periodically review the prevailing socio-economic and other conditions in the Region and if necessary, to determine the applicable daily minimum wage rates;

WHEREAS, the Wage Order of the Department of Labor and Employment is based on a comprehensive study by the National Wages and Productivity Commission for every worker/employee to enable them to cope with the rising cost of living;

WHEREAS, the Wage Order No. RB 1-20 states that the prevailing daily minimum wage rates of workers and employees in Region I should be set at ₱340.00;

WHEREAS, the Local Government Unit of Lingayen deemed it necessary to adopt and set the recommended daily minimum daily wage rates of W.O. No. RB-1-20 to enable its workers and employees to cope with the rising cost of living and to boost their morale and productivity.

WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by all members present, be it:

RESOLVED AS IT HEREBY RESOLVED, to adopt the minimum daily wage of ₱340.00 by Wage Order No. RB 1-20 for the workers/employees of the Local Government Unit of Lingayen.

RESOLVED FURTHER, that the copies of this resolution be furnished the Office of the Mayor, Office of the Municipal Administrator, Human Resource Management Office, and all concerned offices/agencies for their information.


