RESOLUTION NO. 587, S-2022

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE PHILIPPINE STATISTICS AUTHORITY (PSA), REPRESENTED BY ATTY. SHIELA O. DE GUZMAN, REGIONAL DIRECTOR, REGION I, AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY HONORABLE JULIE J. DAQUIOAG, REGIONAL DIRECTOR, REGION I, FOR THE CONDUCT OF CBMS IN THE MUNICIPALITY OF LINGAYEN, PROVINCE OF PANGASINAN.

WHEREAS, the Community-Based Monitoring System (CBMS) is an organized technology-based system of collecting, processing and validating necessary disaggregated data that may be used for planning, program implementation, and impact monitoring at the local level while empowering communities to participate in the process;

WHEREAS, the PSA shall be the lead agency in the implementation of the CBMS pursuant to Republic Act (RA) 11315 also known as the CBMS Act;

WHEREAS, Rules VI, Section 7 of the Implementing Rules and Regulations of the CBMS Act tasked the DILG to develop and implement information and education campaign relating to CBMS; ensure compliance of the LGUs in the various CBMS activities; and extend assistance to PSA in the conduct and implementation of the CBMS;

WHEREAS, Section 4 of the CBMS provides that the LGU is the primary data collecting authority within its locality;

WHEREAS, CBMS will help LGUs properly allocate the bigger tax allotments as a result of the implementation of the Mandanas-Garcia Ruling and to create a proper system and tool to help evaluate, plan, and implement development programs in their localities;


