APPLYING TO THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT I, REPRESENTED BY DR. PAULA PAZ M. SYDIONGCO, MD, MPH, MBA, CESO IV, DIRECTOR IV, FOR THE ISSUANCE OF PERMIT TO CONSTRUCT (PTC) OF THE PROPOSED RURAL HEALTH UNIT-SOUTHERN LINGAYEN AT BARANGAY BASING, LINGAYEN, PANGASINAN.

WHEREAS, the new proposed Rural Health Unit-Southern Lingayen will decongest clients in the two (2) existing RHUs and make quality health services more accessible and convenient to the people of the southern barangays;

WHEREAS, the Municipal Government through the Municipal Health Office is committed to deliver quality health services and meet the growing demands and challenges of the public for as much as the Central and Western RHUs of the municipality already cater to a big chunk of the population;

WHEREAS, the intended construction requires for a Permit To Construct (PTC) from the Department of Health (DOH);

WHEREAS, one of the prerequisites for the application for Permit to Construct (PTC) from the DOH is a Sangguniang Bayan Resolution to effect its establishment;

WHEREAS, this August body deems it necessary to enact a resolution applying to the Department of Health-Center for Health Development I represented by Dr. Paula Paz M. Sydiongco, MD, MPH, MBA, CESO IV, DIRECTOR IV, for the issuance of Permit To Construct (PTC) of the Proposed Rural Health Unit (RHU) Southern Lingayen with the following barangays to serve, namely: Aliwekwek, Basing, Dulag, Lasip, Malawa, Matalava, Naguelguel, Quibaol, Rosario, Talogtog, Tumbar, and Wawa of this municipality;


