APPLYING TO THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT I, REPRESENTED BY DR. PAULA PAZ M. SYDIONGCO, MD, MPH, MBA, CESO IV, FOR THE ISSUANCE OF PERMIT TO CONSTRUCT (PTC) OF THE EXPANSION/UPGRADING OF THE LINGAYEN RURAL HEALTH UNIT AT BARANGAY DOMALANDAN CENTER, LINGAYEN, PANGASINAN.

WHEREAS, pregnant or about to deliver women from the southern Municipal District of Lingayen are prone to deliver their babies at home due to its far geographical distance from nearest hospital;

WHEREAS, to remedy and prevent home delivery, the Rural Health Unit of Western Lingayen intends to construct a birthing facility that will require a Permit To Construct (PTC) from the Department of Health;

WHEREAS, one of the requirements for the application for a Permit to Construct is a Sangguniang Bayan Resolution to effect its establishment;

WHEREAS, this August body deems it necessary to enact a resolution applying to the Department of Health-Center for Health Development I represented by Dr. Paula Paz M. Sydiongco, MD, MPH, MBA, CESO IV, Director IV, for the issuance of Permit To Construct (PTC) of the Expansion/Upgrading of the Lingayen Rural Health Unit at Barangay Domalandan Center, Lingayen, Pangasinan with the following barangays to serve, namely: Baay, Balococ, Balangobong, Bantayan, Capandan, Domalandan Center, Domalandan East, Domalandan West, Estanza, Malimpuec and Sabangan of this municipality;
