WHEREAS, in order not to delay financial transactions in the Sangguniang Bayan, and to ensure the uninterrupted delivery of basic services to the constituents, there is a need to authorize the Acting Vice Mayor to sign all warrants/treasury checks for and in behalf of the Sangguniang Bayan;


WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Ricardo R. Ferrer, be it:
