**RESOLUTION NO. 662, S-2022**

**AUTHORIZING THE HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE SUPPLEMENTARY FEEDING PROGRAM FOR DAY CARE CHILDREN IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN.**

WHEREAS, the Department of Social Welfare and Development (DSWD) is the government agency that is primarily delivering health and social welfare protection services aimed at eradicating malnutrition among children;

WHEREAS, DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life;

WHEREAS, Local Government Units are mandated by law to provide basic services for the general welfare of its constituents;

WHEREAS, the Local Government Unit of Lingayen intends to address malnutrition among children through the Supplemental Feeding Program in Day Care Centers or in any other facility used for such purpose;

WHEREAS, there is a need to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) for strengthened partnership and for more effective implementation of programs, projects, and activities aimed at eradicating malnutrition in the Municipality of Lingayen, Pangasinan;

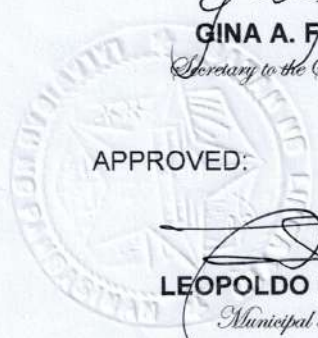
