RESOLUTION NO. 666, S-2022

AUTHORIZING THE MUNICIPAL MAYOR, HON. LEOPOLDO N. BATAOIL, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF LINGAYEN, PANGASINAN, A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE I REGARDING THE ENHANCED KADIWA INCLUSIVE FOOD SUPPLY CHAIN PROGRAM.

WHEREAS, the Department of Agriculture through its Enhanced KADIWA Inclusive Food Supply Chain Program provides financial grants to farmers and fisherfolks to enhance their capacities in the operation and practice of their occupations;

WHEREAS, the Department of Agriculture has included local government units to receive the financial grants intended to support the target beneficiaries;

WHEREAS, through the Program, the LGU will receive a Two Million Pesos (₱2,000,000.00) grant for the purchase of delivery vehicle which will greatly aid the farmers and fisherfolks' operations especially on the transport and distribution of Agri-fishery products;

WHEREAS, the scope and extent of the program, as well as the responsibilities of the parties, are defined in a Memorandum of Agreement (MOA) to be entered into by the Department of Agriculture and the Local Government Unit of Lingayen;

WHEREAS, Section 22 (c) of the Local Government Code of 1991 provides that unless otherwise provided, no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the local Sanggunian;

WHEREAS, after careful perusal, this August Body finds the terms and conditions of the Memorandum of Agreement just and reasonable;


WHEREAS, on motion of SBM Ricardo R. Ferrer, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:


